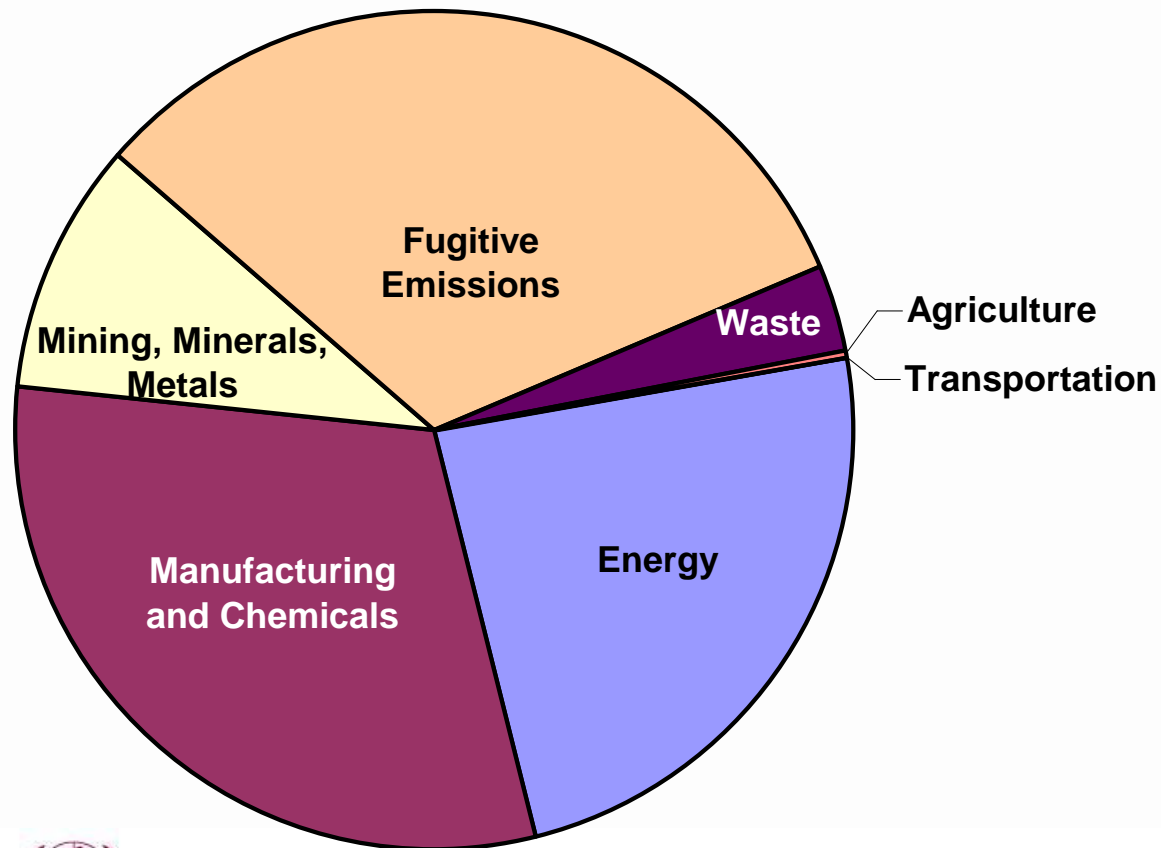

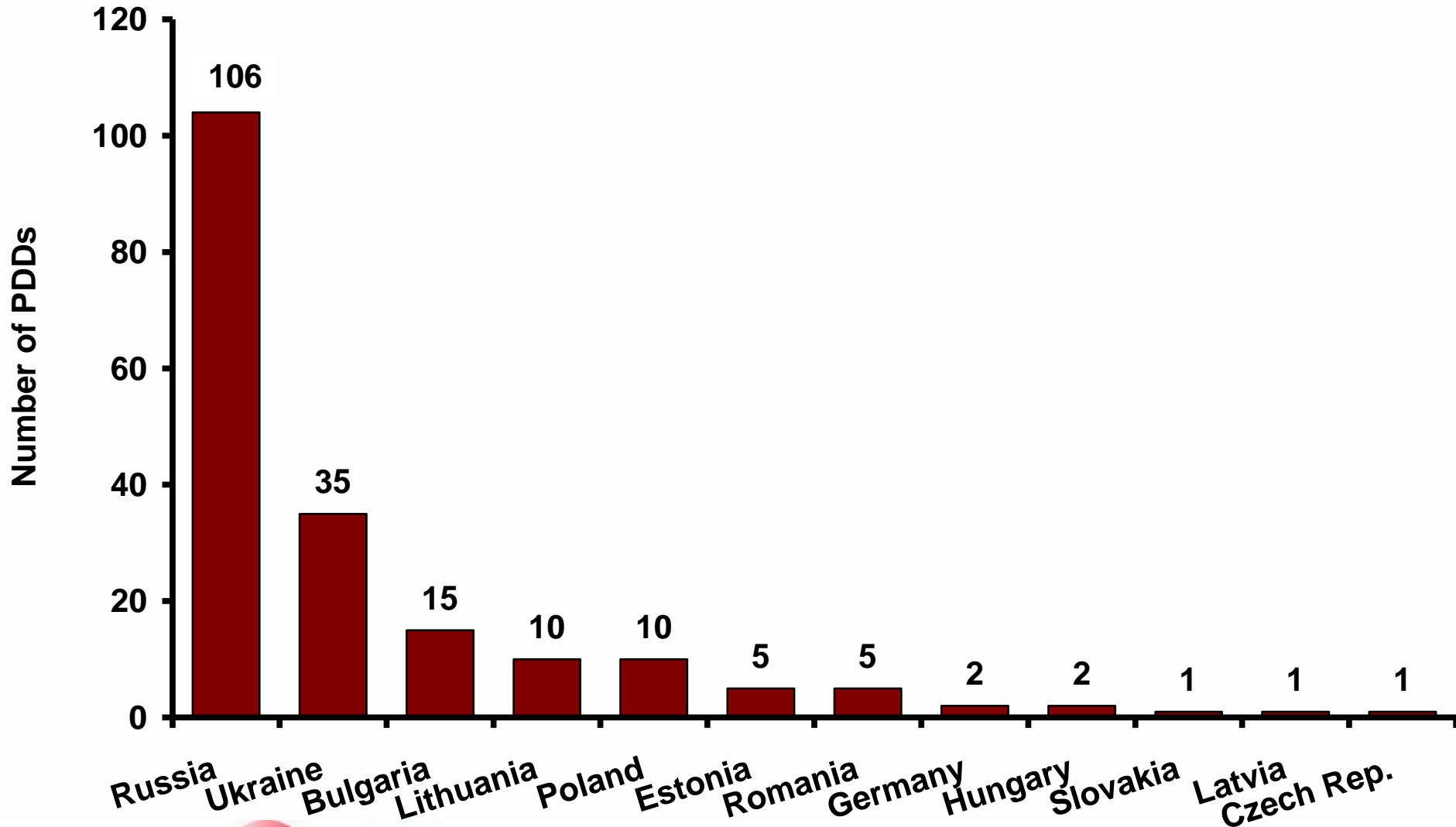
Project design documents (PDDs)
